NO: RESOLUTION 2008-05-143 LIVINGSTON COUNTY DATE: May 5, 2008 RESOLUTION PROCLAIMING JULY 13 - 19, 2008, AS "ROAD RAGE AWARENESS WEEK" -**BOARD OF COMMISSIONERS** WHEREAS, Reaching Out Against Road Rage (R.O.A.R.R.), a non-profit organization located in Muskegon County, has a mission, which consists of the three P's: **Prevention** of Road Rage; **Protection** and support of victims against Road Rage; and, the **Promotion** of life by saving lives; and WHEREAS, to achieve this mission R.O.A.R.R. is promoting awareness and education on the prevention of Road Rage; working in an effort to reduce the number of incidents; and advocate support and assistance to victims and their families in their recovery process; and WHEREAS, the National Highway Traffic and Safety Administration (NHTSA) defines Road Rage as "an assault with a motor vehicle or other dangerous weapon by the operator or passenger(s) of another motor vehicle or an assault precipitated by an incident that occurred on a roadway"; and WHEREAS. a study done by the AAA Foundation indicates an average of at least 1,500 men, women, and children are injured or killed each year in the United States from the violent acts of Road Rage; and WHEREAS. R.O.A.R.R. understands that to solve a problem, we must first be aware of the problem. Road Rage is a growing problem in Michigan as well as in our country; and WHEREAS, R.O.A.R.R. recognizes that young and older drivers face roads of death because of rage in other drivers and themselves: and WHEREAS, we must stop the killing, injuries, and mental anguish; we must work together as a community; and reprogram the destructive attitudes and behaviors that cause Road Rage. WHEREAS, for several years Livingston County has had a contract to provide office space to a drug testing provider in exchange for reduced rates on drug testing services in which the contract expired on December 31, 2007; and

WHEREAS, per the Purchasing Policy, a competitive bid process was performed and the submitted proposals were reviewed; and

WHEREAS, the review committee recommends award to Jail Alternatives for Michigan Services (JAMS) of Pontiac, Michigan, for the rental rate of \$450.00 per month and drug testing services at the rates per Attachment A; and

WHEREAS, the contract period will be July 1, 2008 – June 30, 2010, with the option for the County to renewal for one additional year.

THEREFORE BE IT RESOLVED that the Livingston County Board of Commissioners hereby authorizes entering into a contract with Jail Alternatives for Michigan Services of Pontiac, Michigan, for the rental of 300 square feet of office space located at the A.S.S.E.T. at the monthly rate of \$450.00 and drug testing services at the rates per Option 2 on Attachment A. WHEREAS, the review committee recommends award to Cynergy Wireless Inc., of Troy, Michigan, who submitted the lowest, responsive proposal with pricing as follows:

- ➤ Removal of equipment from a Crown Victoria \$ 175 per vehicle
- ➤ Installation into a fully-marked Crown Victoria \$825 per vehicle
- ➤ Installation into a semi-marked Dodge Charger \$ 900 per vehicle
- ➤ Installation into an unmarked Dodge Caravan \$ 275 per vehicle
- > Parts will be billed at 12% over cost

WHEREAS, the expenditure for Patrol Car Conversions has been planned for and approved in the Sheriff's Department budget for 2008.

THEREFORE BE IT RESOLVED that the Livingston County Board of Commissioners hereby authorizes entering into a contract with Cynergy Wireless of Troy, Michigan, for Patrol Car Conversions for fiscal year 2008 per the pricing as stated above, with an option for an additional one-year renewal period.

RESOLUTION TO APPROVE SOLID WASTE CHALLENGE GRANT PROGRAM DESCRIPTION AND APPLICATION FORM FOR 2008 - Drain Commissioner's Office, Solid Waste Program / Infrastructure & Development Committee

WHEREAS, \$25,000 is allocated for 2008 for line item 441-956.000 for the purpose of encouraging new or improved solid waste reduction programs, environmental education programs, or continuing existing programs; and

WHEREAS, local units of government are eligible for project funding assistance and they may partner with other local units of government or non-profit organizations; and

whereas, approximately \$22,500 will be allocated for community clean-ups and other one-time projects for local units of government. Partnerships are highly encouraged, will be given preference over individual projects, and will be eligible for a higher percentage of match from the county (from 25% to 40% or maximum of \$1,800 to \$3,500). Local units can apply for more than one solid waste challenge grant, however, the maximum amount of grant funds per local unit of government is \$3,500; and

WHEREAS, approximately \$2,500 will be allocated for long term projects intended to produce a decrease on the waste stream which would otherwise be landfilled; and

WHEREAS, successful grant applicants will be required to enter into an agreement with Livingston County, provide applicable proofs of insurance, and submit receipts to the Solid Waste Program prior to being reimbursed for expenses.

THEREFORE BE IT RESOLVED that the Livingston County Board of Commissioners hereby approves the Solid Waste Program for 2008 and authorizes the Public Works Coordinator to distribute the Solid Waste Challenge Grant Program description and application to local units of government.

RESOLUTION AUTHORIZING PURCHASE OF REAL PROPERTY - COUNTY ADMINISTRATION

WHEREAS, for the past 8 years, the headquarters of the Livingston County Emergency Medical Service has been at the Intermodal Building; and

WHEREAS, the lease for this space will expire in 2009; and

WHEREAS, the needs of the EMS have grown beyond the space available at the Intermodal Building; and

WHEREAS, the University of Michigan Survival Flight Service has approached the Livingston County EMS with the opportunity to partner in a building; and

WHEREAS, this partnership is clearly in the benefit of the residents, visitors, and businesses of Livingston County; and

WHEREAS, because of the need for U of M Survival Flight to have access to the Livingston County, Spencer J. Hardy Airport, the first step is the acquisition of a site of sufficient size to accommodate a joint facility.

THEREFORE BE IT RESOLVED that the Livingston County Board of Commissioners hereby authorizes the purchase of a 12.35 acre parcel contiguous to the Livingston County, Spencer J. Hardy Airport in an amount of \$440,000 plus any closing costs and commissions in the amount of \$21,200. Funds for this expenditure are available in the 2008 EMS Budget.

BE IT FURTHER RESOLVED the Chairman of the Board is hereby authorized to sign any documents relating to this purchase upon review of civil counsel.
