5. **ARCHITECTURAL UPDATE:**

- County Architect Mike Kennedy updated members on timelines involved with pre-construction matters, as well as going over the most recent design plans.

COMM. PARKER REQUESTED ROAD NAMES AND COLOR-CODING BE ADDED TO PROPOSED JAIL PLANS DIFFERENTIATING ORIGINAL JAIL LAYOUT, LAST ADDITION AND PROPOSED ADDITION.

- Discussion took place regarding space needs for things such as: parking, kitchen, laundry, locker and evidence rooms.
- Restrictions for Preliminary Exams and use of video technology was discussed with regard to inmate transport.
- Undersheriff Murphy and Lt. Cremonite concurred that the present design significantly reduces inmate movement throughout the facility. It was felt that this could be even more reduced with use of video technology by Defense Counsel, Prosecutors and Judges.
- Discussion took place regarding the Prisoner Rape Elimination Act (PREA) that is imposed upon federal and state penitentiaries.
- Comm. Griffith questioned the feasibility of testing out bed rental relationship with the US Marshall's office. The Undersheriff confirmed that details were presently being worked out.

6. PROJECTED OPERATIONAL COST FORMULA:

- Increases from RQAW Jail Study were discussed, i.e. 24/7 health care, staffing projections, etc.
- Currently looking at \$2.3 Million increase in annual expenses for expansion versus' RQAW quote of \$1.9 Million.
- Allowable bond fund expenditures were discussed, i.e. technology versus operational costs, etc.
