FILING REQUIREMENTS**

**WHERE TO FILE:**

**WHEN TO FILE:**

Candidates must file by **4:00 p.m. on Thursday, July 21, 2022.**

Candidates will appear on the November 8, 2022 General Election.

- **Candidates Who Wish to Withdraw**

Candidates must withdraw, in writing, with their filing official by 4:00 p.m. on Monday, July 25, 2022.

**QUALIFICATIONS:**

Must be a citizen of the United States and a qualified and registered elector of the library district the candidate seeks to represent by the filing deadline.

**WHAT TO FILE:**

**1. AFFIDAVIT OF IDENTITY**

All candidates must submit an Affidavit of Identity when filing for office.

A candidate who fails to file an Affidavit of Identity as required is ineligible to appear on the ballot. Candidates filing an Affidavit of Identity must agree with the facts set forth in the "Campaign Finance Compliance Statement" (MCL 168.558, 993 and 936). Therefore, a candidate may not have any outstanding notices of failure to file or late fees with any filing official in the state.

**2. FILING FEE OR NOMINATING / QUALIFYING PETITIONS**

Candidates seeking the office of District Library Board Member may file a \$100.00 nonrefundable fee in lieu of a petition.

- **Petition Signature Requirements**

Petition signature requirements are based on population of the district according to the census.

	Population Federal Census	Petitions

<b>Library Districts</b>	<b>10,000 or more</b>	<b>40</b>	<b>100</b>

Signatures must be by qualified and registered electors of the library district.

Candidates use the City/Township Non-Partisan Nominating Petition.

### **FILING REQUIREMENTS FOR WRITE-IN CANDIDATES:**

A candidate who wishes to seek election to the office of District Library Board Member with write-in votes must file a Declaration of Intent with the appropriate filing official no later than 4:00 p.m. on Friday, October 28, 2022.

### **CAMPAIGN FINANCE:**

All candidates are required to comply with the [Campaign Finance Act](#) filing requirements and file at the County Clerk Elections Division.

The following City/Townships are within the Brighton District Library boundaries:

#### **Brighton City**

Precincts 1, 2, 3, & 4

#### **Brighton Charter Township**

Precinct 1, 3, 4, 5, 8, & 9

#### **Genoa Charter Township**

Precincts 4, 6, 7, & 8

#### **Green Oak Charter Township**

Precincts 1, 2, 3, 4, 5, 6, 7, 8, & 9
