FILING REQUIREMENTS**

**WHERE TO FILE:**

**WHEN TO FILE:**

Candidates must file by **4:00 p.m. on Tuesday, April 23, 2024.**

Candidates will appear on the November 5, 2024 General Election.

Note: if there are more than twice the number of candidates file as there are persons to be elected, then Candidates will appear on the August 6, 2024 Primary Election. (MCL 168.540).

- **Candidates Who Wish to Withdraw**

Candidates must withdraw, in writing, with their filing official by 4:00 p.m. on Friday, April 26, 2024.

**QUALIFICATIONS:**

Must be a citizen of the United States and a qualified and registered elector of the library district the candidate seeks to represent by the filing deadline.

**WHAT TO FILE:**

**1. AFFIDAVIT OF IDENTITY**

All candidates must submit an Affidavit of Identity when filing for office.

A candidate who fails to file an Affidavit of Identity as required is ineligible to appear on the ballot. Candidates filing an Affidavit of Identity must agree with the facts set forth in the "Campaign Finance Compliance Statement" (MCL 168.558, 993 and 936).

Therefore, a candidate may not have any outstanding notices of failure to file or late fees with any filing official in the state.

## **2. FILING FEE OR NOMINATING / QUALIFYING PETITIONS**

Candidates seeking the office of Township Library Board Member may file a \$100.00 nonrefundable fee in lieu of a petition.

- **Petition Signature Requirements**

Petition signature requirements are based on population of the district according to the census.

Township Population	10,000 or more	40	100

Signatures must be by qualified and registered electors of the library district.

Candidates use the City/Township Non-Partisan Nominating Petition.

### **FILING REQUIREMENTS FOR WRITE-IN CANDIDATES:**

A candidate who wishes to seek election to the office of Township Library Board Member with write-in votes must file a Declaration of Intent with the appropriate filing official no later than 4:00 p.m. on Friday, October 25, 2024.

Note: If there is an August Primary, a write-In candidate must file no later than 4:00 p.m. on Friday, July 26, 2024.

### **CAMPAIGN FINANCE:**

All candidates are required to comply with the [Campaign Finance Act](#) filing requirements and file at the County Clerk Elections Division.
