I. Call to order

Hansel Keene called to order the regular meeting of the Livingston County Veteran's Council at 7:00 pm on April 26, 2017 at Livingston County Veteran Services.

II. Roll call

III. Approval of minutes from last meeting

Hansel Keene called for approval of minutes from MARCH 8, 2017.

IV. Applications for Relief- Hansel confirmed that all participants are in county and have honorable discharges.

- a) 17-SC. Asking for relief of home repair \$3000 trench for sewer repair. Hook up \$14, 220 for total \$17, 220; Kevin Nagle Motions for application to be tabled until applicants come in and address the committee. Committee denies application because they are over the federal guidelines for assistance.

- c) 17-034. Roof repair \$9800, Hundley moves to approve application; Nagle seconds; no discussion committee approves; Burton Construction was approved to start.
- d) 17-035.- Requesting assistance on rent and electric \$1800 rent; electric bill \$1036; assistance for 3 months on sober link; and counseling Motion for payment of electric; second by Nagle; approved for electric only. Committee will entertain rent and further assistance idea if parties want to come in and discuss matter.
- e) 17-021.-Application for vehicle repair; Motion for repair by Wallace; Second Nagle; Approved
- f) 17-032.- Requesting assistance for some bills due to truck repair requesting assistance for water, electric, and gas credit card \$1270.35. Nagle motions for payment; Hundley seconds; Approved

- a) 17-094.- Nagle motions to reject application; Wallace seconds; Denied
- b) 17-040.- Bathroom falling through floor; Requesting \$8470 for repair; Nagle motions for \$8470 to be paid for repairs on property with lien on property. Second by Hundley; Verify property is in veteran's name and no liens; Approved
