I. Call to order

Kevin Nagle called to order the regular meeting of the Livingston County Veteran's Council at 7:03 pm on June 8, 2017 at Livingston County Veteran Services.

II. Roll call

Hansel Keene conducted a roll call. The following persons were present: Jim Wallace, Bruce Hundley, Hansel Keene, and Kevin Nagle

III. Approval of minutes from last meeting

Hansel Keene – Jim Wallace motions for last meeting minutes to be approved; Kevin Nagle seconds; all in favor- **APPROVED**

IV. Applications for Relief- Hansel Keene confirmed that all participants are in county and have honorable discharges.

Hansel seconds; No discussion all in favor Wallace; Keene; Nagle; Opposed- Hundley.

- b) 17-040 addressed repair and placing lien on property Brandon Denby will be willing to come in and discuss the process. Need to develop contract for veterans to sign informing them of the lien process. Committee approves \$8470 and lien to be placed. Need to get an opinion on how to file lien and file it.
- c) 17-037 application for ramp and scooter; Applicant is returning home; Kevin Nagle motions for denial of application exceeds guidelines; Bruce Hundley seconds; no further discussion; Motion Approved

- d) 17-036 application for rent and medical bill; Motion by Wallace; Keene Second; no further discussion; Approved
- e) 17-039 vehicle repair \$1399.17; Divorced; paying child support; legal fees; Wallace motions; HUNDLEY seconds; no further discussion; Nagle abstains all in favor; Approved
- f) 17-MM-application for assistance to pay bills that are on credit report.\$2460 total. Motion to table by Nagle; Keene seconds; no further discussion; Approved
